**Code of Conduct  
to  
Regulate, Monitor and Report Trading by Insiders**

**I. Introduction**

This Code of Conduct to Regulate, Monitor and Report Trading by Insiders (hereinafter referred to as "the Code") has been framed to avoid any Insider Trading in the securities of the Company by the persons in possession of Unpublished Price Sensitive Information.

**II Effective Date**

The Code shall come into force immediately.

**III Definitions**

**"Act"** means the Securities and Exchange Board of India Act, 1992.

**"Board / Board of Directors"** shall mean the Board of Directors of the Company

**"Code"** or **"Code of Conduct"** shall mean the Code of Conduct to Regulate, Monitor and Report Trading by insiders of the Company as amended from time to time.

**"Company/SEML"** shall mean Sarda Energy & Minerals Ltd.

**"Compliance Officer"** shall mean Company Secretary or such other senior officer, who is financially literate and is capable of appreciating requirements for legal and regulatory compliance under these regulations designated so and reporting to the Board of Directors and who shall be responsible for compliance of policies, procedures, maintenance of records, monitoring adherence to the rules for the preservation of unpublished price sensitive information, monitoring of trades and the implementation of the codes specified in these regulations under the overall supervision of the Board of Directors of the Company.

**"Connected Person"** means:

- i) any person who is or has during the six months prior to the concerned act been associated with a company, directly or indirectly, in any capacity including by reason of frequent communication with its officers or by being in any contractual, fiduciary or employment relationship or by being a director, officer or an employee of the Company or holds any position including a professional or business relationship between himself and the Company whether temporary or permanent, that allows such person, directly or indirectly, access to unpublished price sensitive information or is

reasonably expected to allow such access.

- ii) Without prejudice to the generality of the foregoing, the persons falling within the following categories shall be deemed to be connected persons unless the contrary is established:
- a) an immediate relative of connected persons specified in clause (i); or
  - b) a holding company or associate company or subsidiary company; or
  - c) an intermediary as specified in Section 12 of the Act or an employee or director thereof; or
  - d) an investment company, trustee company, asset management company or an employee or director thereof; or
  - e) an official of a stock exchange or of clearing house or corporation; or
  - f) a member of board of trustees of a mutual fund or a member of the board of directors of the asset management company of a mutual fund or is an employee thereof; or
  - g) a member of the Board of directors or an employee, of a public financial institution as defined in section 2 (72) of the Companies Act, 2013; or
  - h) an official or an employee of a self-regulatory organization recognised or authorized by the Board; or
  - i) a banker of the Company who have access to or could access UPSI about the company by virtue of any connection that would put them in possession of UPSI; or
  - j) a concern, firm, trust, hindu undivided family, company or association of persons wherein a director of the Company or his immediate relative or banker of the Company, has more than ten per cent, of the holding or interest.

**"Dealing in Securities"** means an act of subscribing to, buying, selling or agreeing to subscribe to, buy, sell or deal in the securities of the Company either as principal or agent.

**"Designated Persons"** shall mean and include all persons covered under **Appendix-II** to this Code.

**"Director"** means a member of the Board of Directors of the Company.

**"Immediate Relative"** means a spouse of a person, and includes parent, sibling, and child of such person or of the spouse, any of whom is either dependent financially on such person, or consults such person in taking decisions relating to trading in securities;

**"Insider"** means any person who is,

- a) a connected person; or
- b) in possession of or having access to unpublished price sensitive information.

**"Promoter"** shall have the meaning assigned to it under the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2009 or

any modification thereof:

**"Regulations"** means Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations 2015, and includes amendments and modifications as may be effected by SEBI from time to time.

**"SEBI"** means Securities and Exchange Board of India.

**"Securities"** shall have the meaning assigned to it under the Securities Contracts (Regulation) Act, 1956 (42 of 1956) or any modification thereof except units of a mutual fund;

**"Takeover regulations"** means the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and any amendments thereto;

**"Trading Day"** means a day on which the recognized stock exchanges are open for trading;

**"Unpublished Price Sensitive Information [UPSII]"** shall mean all or any of the following:

- a) financial results
- b) Declaration of dividends (interim and final)
- c) change in capital structure
- d) mergers, de-mergers, acquisitions, delistings, disposals and expansion of business and such other transactions
- e) Changes in key managerial personnel
- f) material events in accordance with the listing agreement.

Words and expressions used and not defined in this Code / Regulation but defined in the Securities and Exchange Board of India Act, 1992 (15 of 1992), the Securities Contracts (Regulation) Act, 1956 (42 of 1956), the Depositories Act, 1996 (22 of 1996) or the Companies Act, 2013 (18 of 2013) and rules and regulations made thereunder shall have the meanings respectively assigned to them in those legislation.

#### **IV Role of Compliance Officer**

1. The Compliance Officer shall report on insider trading to the Board of Directors of the Company and in particular, shall provide reports to the Chairman of the Audit Committee at such frequency as may be stipulated by the Board of Directors.
2. The Compliance Officer shall assist all employees in addressing any clarifications regarding the Securities & Exchange Board of India (Prohibition of Insider Trading)

### **V Preservation of Unpublished Price Sensitive Information**

- 1 Designated Persons shall maintain the confidentiality of all Price Sensitive Information. They should not pass on such information to any person directly or indirectly by way of making a recommendation for the purchase or sale of securities.
- 2 The Price Sensitive Information is to be handled on a "need to know" basis, i.e., Price Sensitive Information should be disclosed only to those who need the information to discharge their duty.
- 3 The files containing confidential information shall be kept secure. Computer files shall have adequate security of login and pass word etc.
- 4 The Designated Persons must follow the Company's Code of Practices and Procedures for fair disclosure of Unpublished Price Sensitive Information.
- 5 Notwithstanding anything contained in this Code and or the Regulations, an UPSI may be communicated, provided, allowed access to or procured, in connection with a transaction that would:
  - a) entail an obligation to make an open offer under the takeover regulations where the board of directors of the company is of informed opinion that the proposed transaction is in the best interests of the company;
  - b) not attract the obligation to make an open offer under the takeover regulations but where the board of directors of the company is of informed opinion that the proposed transaction is in the best interests of the company and the information that constitute UPSI is disseminated to be made generally available at least two trading days prior to the proposed transaction being effected in such form as the board of directors may determine.
- 6 For purposes of sub-regulation (5), the board of directors shall require the parties to execute agreements to contract confidentiality and non-disclosure obligations on the part of such parties and such parties shall keep information so received confidential, except for the purpose of sub-regulation (5), and shall not otherwise trade in securities of the company when in possession of unpublished price sensitive information.

### **VI Trading Plan**

1. An insider shall be entitled to formulate a trading plan for dealing in securities of the Company and present it to the Compliance Officer for approval and public disclosure pursuant to which trades may be carried out on his behalf in accordance with such plan.

2. Trading Plan shall
  - a) not entail commencement of trading on behalf of the insider earlier than six months from the public disclosure of the plan;
  - b) not entail trading for the period between the twentieth trading day prior to the last day of any financial period for which results are required to be announced by the issuer of the securities and the second trading day after the disclosure of such financial results;
  - c) entail trading for a period of not less than twelve months;
  - d) not entail overlap of any period for which another trading plan is already in existence;
  - e) set out either the value of trades to be effected or the number of securities to be traded along with the nature of the trade and the intervals at, or dates on which such trades shall be effected; and
  - f) not entail trading in securities for market abuse.
- 3 The Compliance Officer shall review the Trading Plan as above and shall, if in compliance with the requirements, approve the same. However, he shall be entitled to take express undertakings as may be necessary to enable such assessment and to approve and monitor the implementation of the plan as per provisions of the Regulations.
- 4 The Trading Plan once approved shall be irrevocable and the Insider shall mandatorily have to implement the plan, without being entitled to either deviate from it or to execute any trade in the securities outside the scope of the trading plan.

However, the implementation of the trading plan shall not be commenced, if at the time of formulation of the plan, the Insider is in possession of any unpublished price sensitive information and the said information has not become generally available at the time of the commencement of implementation. The commencement of the Plan shall be deferred until such unpublished price sensitive information becomes generally available information. Further, the Insider shall also not be allowed to deal in securities of the Company, if the date of trading in securities of the Company, as per the approved Trading Plan, coincides with the date of closure of Trading Window announced by the Compliance Officer.
- 5 Upon approval of the trading plan, the compliance officer shall notify the plan to the stock exchanges on which the securities are listed.

## VII Trading Restrictions

Designated persons of the company shall be subject to trading restrictions as given hereunder:

### 1. Trading Window

- a) The company shall specify a trading period, to be called "Trading Window", for trading in the company's securities. The trading window shall be closed during the time the information referred to in point VII(2) is un-published.
- b) When the trading window is closed, the Designated persons and their immediate relatives shall not trade in the company's securities during such period.
- c) The time for commencement of closing of trading window shall be decided by the company
- d) ***The Trading Window shall be opened after 48 hours after the information referred to in point VII (2) is made public***

### 2. Closure of Trading Window

The Trading Window shall remain closed from the date of declaration of Board Meeting date at which the matters related to UPSI are proposed to be discussed.

3. The Designated Persons shall conduct all their dealings in the securities of the Company only in a valid trading window and shall not deal in any transaction involving the purchase or sale of the company's securities during the periods when trading window is closed, as referred to in point VII (2) above.
4. In case of ESOPs, exercise of option is allowed in the period when the trading window is closed. However, sale of shares allotted on exercise of ESOPs shall not be allowed when trading window is closed.
5. The Compliance Officer shall intimate the closure of trading window to the designated persons.
6. The trading window shall also be applicable to any person having contractual or fiduciary relation with the Company, such as auditors, accountancy firms, law firms, analysts, consultants etc., assisting or advising the Company that allows such persons, directly or indirectly, access to UPSI.

### 7. Pre-Clearance of Trade

- a) Designated Persons who intend to deal in the securities of the company, when the trading window is open and if the proposed trade is in excess of – 2500 shares or Rs.10 lakhs or such other value as may be specified (market value) or 1% of total issued shares – whichever is less (in one or more lots) over any calendar quarter, should get

their proposed transaction pre-cleared as per the pre-clearance procedure described hereunder.

- b) No designated person shall be entitled to apply for pre-clearance of any proposed trade if such designated person is in possession of unpublished price sensitive information even if the trading window is not closed and hence he shall not be allowed to trade.
  - c) An application may be made in **Appendix III** attached to this Code, to the Compliance officer indicating the estimated number of securities that the designated person intends to deal in, the details as to the depository with which he has a security account, the details as to the securities in such depository and such other details as may be required by any rule made by the company in this behalf.
  - d) The application above in clause (c) should be accompanied by an undertaking in the format given as **Appendix IV**, executed in favour of the company.
8. The Compliance Officer shall, if the application at 7(c) above is approved, issue Pre-clearance Order in format given as **Appendix V**
  9. Designated Persons shall execute their order in respect of securities of the company within one week after the approval of pre-clearance is given. The Designated Person shall file within 2 (two) days of the execution of the order, the details of such execution with the Compliance Officer in the prescribed form (**Appendix VI**). In case the transaction is not undertaken, intimation to that effect must be given to the Compliance Officer.
  10. If the order is not executed within one week after the approval is given, the designated person must get the transaction pre-cleared again.
  11. All Designated Persons who buy or sell any number of shares of the Company shall not enter into an opposite transaction i.e. sell or buy any number of shares during the next six months following the prior transaction. All Designated Persons shall also not take positions in derivative transactions in the shares of the Company at any time. In case of any contra trade be executed, inadvertently or otherwise, in violation of such a restriction, the profits from such trade shall be liable to be disgorged for remittance to the Securities and Exchange Board of India (SEBI) for credit to the Investor Protection and Education Fund administered by SEBI under the Act.

In case of subscription in the primary market (initial public offers), the above mentioned entities shall hold their investments for a minimum period of 30 days. The holding period would commence when the securities are actually allotted.

12. In case the sale of securities is necessitated by personal emergency, the holding period

may be waived by the compliance officer after recording in writing his /her reasons in this regard. However, no such sale will be permitted when the Trading window is closed.

### VIII Reporting Requirements

Designated Persons shall be required to forward following details of their Securities transactions including the statement of dependent family members (as defined by the company) to the Compliance officer.

#### Initial Disclosure

1. Every promoter/ Key Managerial Personnel/Director/Officer/Designated Persons of the Company, within thirty days of the regulations taking effect, shall forward to the Company the details of all holdings in securities of the Company presently held by them including the statement of holdings of dependent family members in the prescribed Form – **Appendix VII**.
2. Every person on appointment as a key managerial personnel or a director of the Company or upon becoming a promoter shall disclose his holding of securities of the Company as on the date of appointment or becoming a promoter, to the Company within seven days of such appointment or becoming a promoter – **Appendix VII**

#### Continual Disclosure

3. Every promoter, employee and director of the Company shall disclose to the Company the number of such securities acquired or disposed of within two trading days of such transaction (**Appendix VIII**) if the value of the securities traded, whether in one transaction or a series of transactions over any calendar quarter, aggregates to a traded value in excess of Rs.10,00,000/- (Rupee ten lakhs only). The disclosure shall be made within 2 working days of:
  - a) the receipt of intimation of allotment of shares, or
  - b) the acquisition or sale of shares or voting rights, as the case may be.
4. Disclosure by the Company to the Stock Exchange(s)
  - a) Within 2 days of the receipt of intimation under Clause VIII (3), the Compliance Officer shall disclose to all Stock Exchanges on which the Company is listed, the information received.
  - b) The Compliance officer shall maintain records of all the declarations in the appropriate form given by the directors / officers / designated employees for a minimum period of five years.
5. Disclosures by other connected persons

The Company may, at its discretion require any other connected person or class of connected persons to make disclosures of holdings and trading in securities of the

company in such form and at such frequency as may be determined by the Company in order to monitor compliance with these regulations.

6. The Compliance officer shall place before the Audit Committee, on a quarterly basis all the details of the dealing in the securities by designated persons of the company and the accompanying documents that such persons had executed the trade(s) under the pre-dealing procedure as envisaged in this code.

### **IX Other Requirements**

1. The disclosures to be made by any person under this Code shall include those relating to trading by such person's immediate relatives, and by any other person for whom such person takes trading decisions.
2. The disclosures of trading in securities shall also include trading in derivatives of securities and the traded value of the derivatives shall be taken into account for purposes of this Code.
3. The disclosures made under this Code shall be maintained for a period of five years.

### **X Penalties**

1. Every Designated Person shall be individually responsible for complying with the provisions of the Code (including to the extent the provisions hereof are applicable to his/her dependents).
2. Any Designated Person who trades in securities or communicates any information for trading in securities in contravention of the code of conduct may be penalised and appropriate action shall be taken by the company.
3. Designated Persons who violate the code of conduct shall also be subject to disciplinary action by the company, which may include salary/wage freeze, suspension, ineligibility for future participation in employee stock option plans, etc.
4. The action by the company shall not preclude SEBI from taking any action in case of violation of SEBI (Prohibition of Insider Trading), Regulations, 2015

### **XI. Review**

The Code has been framed/adopted by Sarda Energy & Minerals Limited (hereinafter referred to as "the Company") in compliance with the provisions of the Regulations. In case of any subsequent changes in the provisions of the Regulations which makes any of the provisions in this Code inconsistent with the Regulations, the provisions of the

Regulations would prevail over the Code and the provisions in the Code would be modified in due course to make it consistent with the Regulations.

This Policy shall be reviewed by the Board of Directors as and when any changes are to be incorporated in the Code due to change in Regulations or as may be felt appropriate by the Board.

Every Designated Person (both present and future) shall acknowledge receipt of the Code or any modification(s) thereto, in the form annexed to this Code as **Appendix - I** and forward the same to the Compliance Officer.

Any breach of the aforesaid Code brought to the notice of the Compliance Officer or any member of the Board or Senior Management shall be reported to the Board of Directors of the Company for necessary action.

### **XIII. Dissemination**
