

<u>PART – F</u>

None of the waste generation is hazardous from toxicity point of view. Only spent oil/ used oil, and Cotton rags is being generated as Hazardous waste. The solid waste generated is overburden (Topsoil, Sandstone & Shale) from mining operation. Topsoil is being stacked separately to be topped on the reclaimed area and plantation will be done.

Sandstone and Shale etc. is being stacked separately. This overburden dump will be back filled. OB dump height is proposed to be a maximum 60 Meters, terraced and planted when dump is not in use. The overall slope angle is proposed to be 28 degrees. Back filling work has been started in the de-coaled area and plantation is being started.

The following steps have been taken for pollution control:

- 1. We have installed fixed sprinklers on haul road, rain guns and wind breakers around the coal stock yard for controlling fugitive emissions.
- 2. We have installed ETP with EQMS, Oil/grease separator, and three settling tanks with flow meter and PTZ camera.
- 3. We have constructed settling tanks, sumps, siltation ponds and soaks pits which will conserve and augment ground water levels.
- 4. We have constructed catch drains, garland drains, siltation ponds and retaining walls. Water collected in sumps/dumps has been used for greenbelt development and dust suppression as per the imposed condition.
- 5. Desilting of garland drains made in the mine with check dams for stormwater management, to reduce the erosion of the topsoil and stacks and to control solid particulates from going to nearby Nalla, had been pre-monsoon and two times during monsoon.
- 6. To reduce vibration, Surface miner and control blasting techniques are being used.
- 7. The OB dump is being stacked at earmarked dump site and will not be active for a long period.
- 8. Proper terracing of OB dump is being carried out and over the slop of the dump not exceeds 28 degree.
- 9. Catch drains & siltation ponds are constructed to arrest silt and sediment flows from soil, Over Burden dumps.
- 10. The total no. of sapling planted in our Coal mine cumulates to be 42,370 by the end of March 2024.
- 11. Transportation of coal from the mine is being done after covering the coal by tarpaulin in the trucks.
- 12. Environmental Monitoring cell has been formed.
- 13. Oil trap & settling tank has been constructed.

PART - H

- 1. More frequent sprinkling and water spraying is proposed for environmental protection in the Open Cast Coal Mine.
- 2. The plantation work is also proposed in the coming years to improve the green belt thickness, for this purpose approximately 33,600 Nos. of trees will be planted in the year 2024–25.
- 3. Desilting of garland drains and check dams will continue before monsoon next year.
- 4. Proposal for Environmental Monitoring Lab.
